PRESIDENT'S REPORT

One year ago, I wrote that the history of JCIDC "has been a great run," and as I review 2023 and look ahead to our 40th anniversary in 2024, I'm challenged to come up with a better phrase to use!

Last year, we saw one of the largest announcements for new investment occur; saw the conclusion of a comprehensive study by a nationally recognized firm; saw the implementation of a long-awaited training program; and saw the area continue to improve in national rankings for economic vitality. Bottom line ... 2023 was another terrific year for our organization as we celebrated our 39th anniversary.

In June, Walmart announced plans to invest \$108 million at its regional distribution center in Seymour as part of its overall growth plans. It is expected this investment is just the start of additional renovation plans in the coming years.

Walmart was one of nine successful projects during the year that saw nearly \$185.9 million

in "promised investment" announced. Since the Walmart investment will occur in 2024, that investment will be included among those which will occur this year. During 2023, Aisin U.S.A. Manufacturing Inc., Valeo, Cummins and O&K American Corp. announced major projects, as did E&H Tubing and S&J Excavation, both in Brownstown, and Seymour's newest company, United Pipe and Tube.

Those investments, plus the new jobs created and those retained, helped keep Jackson County's unemployment rate below state and national average and kept Seymour among the top micropolitans in the country.

POLICOM's annual study ranked Seymour 59th out of 543 micropolitans in the U.S. (A micropolitan area must have a city of at least 10,000 people but less than 50,000. Indiana has 26 such areas, and Seymour ranked #2 in the state). Last year, Seymour was ranked 76th, and it is the ninth straight year that Seymour ranked in the top 100.

Work also continued on the state of Indiana's READI (Regional Economic Acceleration and Development Initiative) 2.0 program. Jackson County previously joined with Bartholomew and Jennings counties to form the South Central Indiana Talent Region, which was awarded nearly \$30 million in late 2021. Over \$7 million was designated for Jackson County projects and included workforce development/training, infrastructure and medical projects. Among those projects was the start of the Vincennes University maintenance training program.

In the works for years, the partnership with Vincennes became official in early November when a ribbon-cutting ceremony was held at the Jackson County Learning Center. Before the end of the year, the first two classes had completed their initial training. Support from the Seymour Redevelopment Commission as well as the Aisin companies of Jackson County, Valeo and Cummins allowed the project to occur, and expansion of that program already is being discussed as possible uses of READI 2.0 funds.

Those READI funds also are expected to come into play as the result of the Brookings Institution study, which was completed in 2023. Seymour-Jackson County had been selected by the Indiana Economic Development Corporation to be included in a study by the nationally known Brookings Institution. Many residents and other organizations were asked to participate in meetings as the future of the area was discussed before the report was completed and released in the third quarter of the year. **UPDATE in March 2024:** As this newsletter was prepared to go to press, several issues were raised in the community concerning the Brookings study. As a result, the future of READI 2.0 funds being used in Jackson County were in jeopardy in advance of the mid-April READI awards to be announced by IEDC.

REMC, PEOPLES BANK JOIN JCIDC BOARD OF DIRECTORS

At the JCIDC annual board meeting in February, it was announced two longtime contributors had decided to make Board-level contributions and that several other supporters were increasing their donations.

"We are pleased to report that The Peoples Bank and Jackson County REMC are now members of the board of directors," said Marvin Veatch, JCIDC treasurer who also heads up the Resource Development committee. "REMC returns after having previously being on the board, and we're happy to welcome The Peoples Bank," he said, adding that Mark McKinney, president and CEO of REMC, and Will Spray, vice president of The Peoples Bank, have joined the board to represent those organizations.



CUMMINS. DICKSONS ANNOUNCE PLANS FOR EXPANSION

Two Seymour companies announced plans for projected investment of more than \$20 million during first quarter of 2024.

During a meeting on February 12th, the Seymour City Council approved tax abatement for Cummins and Dicksons Inc., as well as Templeton Commercial Properties LLC, the real estate arm of Dicksons' parent company.

Cummins submitted statements of benefits (two real estate improvement and three personal property) for different projects within the company's Seymour Engine Plant along East Fourth Street Road. The real estate improvements total \$4.3 million, while the three personal property investments total \$13,022,041. The real estate improvements will allow for expansion and facility improvements to its Seymour campus and capacity expansion of the Hedgehog line, while the personal property investments include manufacturing equipment for Project GZO4, expansion of the Seymour Technical Center with machinery, test cells and facilities and machinery and equipment for the expansion of the Hedgehog line.

Templeton Commercial applied for a 10-year tax abatement on new investment of \$3,464,100 for construction of a 58,575-square-foot expansion to its Dicksons Inc. building at 2025 First Ave. in the Freeman Field Industrial Park. In addition, Dicksons received a 10-year tax abatement on the purchase of \$408,500 in new logistics equipment.

The expansions will allow Dicksons to retain its current workforce of 68 with a payroll of \$2,849,000, and Cummins will retain its workforce of 881 with a payroll of more than \$78 million.

During the meeting, Jim Plump of JCIDC also reported on Cummins' compliance with statement of benefits for 15 personal property and 11 real property investments. The total amount of personal property investment on the abatements over the last 10 years was \$103.861.335, and the total for real property was \$53,236,080. The initial projections were 433 employees and \$33.7 million in payroll, but both numbers have nearly or more than doubled.

SEYMOUR'S NATIONAL **RANKING IMPROVES**

1ST QUARTER 2024

Seymour gained 17 places in the annual POLICOM rankings for micropolitan areas with the 2024 rankings showing Seymour ranking 59th out of 543 micropolitans across the United States.

A micropolitan area must have a city of at least 10,000 people but fewer than 50,000. Economic Strength is the long-term tendency for an area to consistently grow in both size and quality. POLICOM considers 23 economic factors over a 20-year period to determine the strength of an area.

Seymour broke into the top 100 in 2016 and has remained there for nine straight years. Over the past five years, the Jackson County community was ranked 76th in 2023, 56th, 83rd and 97th. Since micropolitan areas are relatively small, thus less diversified, they are subject to rapid economic change, causing them to fluctuate, year by year, in POLICOM's rankings.

There are 26 micropolitans in the state of Indiana; Seymour ranks second behind only Washington, which is 21st this year after a 49th rating in 2023.
